### ***The main directions of the conference:***

- I. Species and varieties of representatives of the genus *Syringa* L.: collections formation, study, exhibit and use;
- II. Modern directions of selection of representatives of the genus *Syringa* L. : practice and areas of work;
- III. Growing technologies and methods of propagation of plants of the genus *Syringa* L.;
- IV. Lilac in culture and art.

### ***Forms of participation in the conference:***

- 1) Participation in an online conference as a speaker (in videoconference mode with a video camera on) without arriving at the conference venue. To participate, you must have a stable Internet connection and a camera (for video and sound transmission).
- 2) Participation in an online conference as a listener (getting access to a video conference). To participate, you must have a stable Internet connection and a camera (for video and sound transmission).
- 3) Only publication in an electronic collection, which will be posted in the section dedicated to the conference, on the BIN RAS site, with subsequent indexation in the RSCI (Russian Science Citation Index) and in the electronic library **E-library**.

**The registration fee** for participation in the conference is set at 500 rubles (includes, among other things, the publication of 1 article in the collection). For the publication of each subsequent article by the author, regardless of the form of participation the fee is 100 rubles.

**The last day for accepting articles for consideration and publication is February 07, 2021.**

**The collection of conference articles will be sent to the participants in electronic form.**

***Instructions for formatting articles:***

1. Materials are accepted in .doc, .docx or .rtf format at [botanical\\_garden\\_spb@mail.ru](mailto:botanical_garden_spb@mail.ru). Each article should be in a separate file. The file name has to coincide with the name of the first author, for example, if the first author is T. Ivanov, then the file name is Tlvanov\_01.doc, the second work of this author Tlvanov\_02.doc, etc.
2. The volume of materials is up to 5 A4 pages with margins of 2.5 cm on all sides, font Times New Roman, size 11, after 1 interval. The text should be aligned in width, paragraph indent 1 cm, automatic hyphenation.
3. The text should be stated in the following order: UDC, title (printed in lower case, centered, in bold), under the name of the authors and their place of work (the full name of the institution / organization / enterprise, as well as E-mail, city, country). This is followed by an abstract (up to 100 words), keywords (4-5). The bibliographic list is placed after the text of the publication and must comply with GOST R 7.0.5-2008 "System of standards for information, library and publishing. Bibliographic reference. General requirements and compilation rules."

Upon receipt of applications and materials, the Organizing Committee within 3 working days sends a letter back to the author's address confirming their receipt. Participants who do not receive confirmation must duplicate the materials or contact the Organizing Committee by phone.

The organizing committee reserves the right to select, scientific editing and proofreading of the text, as well as to make stylistic changes in the text without agreement with the authors, to determine the form of the report (plenary, sectional) and reserves the right to reject articles not on the topic of the conference or of low quality.
